



REGULATIONS

70th Anniversary Vespa Club Verona

1st September 2019



Art. 1 - Vespa Club VERONA organizes a National meeting with International Participation for its 70th anniversary. This will take place on Sunday, September 1st, 2019 and is called "*LXXale del Vespa Club Verona*" (70 years Vespa Club Verona).

Art. 2 - All members of the Vespa Club Verona, the Vespa Club d'Italia and the Vespa World Club are entitled to participate.

Art. 3 - The participation fee is Euro 35,00 for both drivers and passengers. This includes welcome breakfast, participant's kit, event gadget, guided city tours and restaurant lunch.

Art. 4 - Vespa riders from Italy should register through their Vespa Club on the Vespa Club Italia (V.C.I.) Internet portal.

Upon receipt of the registration fee by bank transfer, an entry confirmation will be sent by the organization.

Vespa drivers from abroad can sign up through the registration form. This shall be requested to the Organising Committee, duly filled and sent, together with payment confirmation of the registration fee, by e-mail to following email address: LXXverona@gmail.com.

Entries are accepted up to 7 days before the event, or until the day of the event, if the maximum number of participants has not already been reached.

If the maximum number of participants (350) is reached, entries will be closed and no further entries will be accepted.

Art. 5 - Each Vespa Club responsible will report in Verona on *Lungadige San Giorgio* to check the registration of his group and to collect the kits for his group members.

Art. 6 - By registering for the event, the participant confirms his consent for the use of his personal data exclusively for the purpose of event management, and, if necessary, for the publication of photos and video footage of the event on newspapers, magazines, websites, social networks and other media that should show him and / or his vehicle and renounces any claim against copyright infringement.

Art. 7 - Responsibility. The organizers reject any civil and criminal liability for any accident in which the event participant was involved or should cause to third parties before, during and after the event.

By registering for the event, the participant declares to know this regulation and to accept it in its entirety.

The event takes place on public roads; therefore, all vehicles must comply with the traffic regulation rules requirements.

Drivers should follow the instructions of the authorities and the event organization staff.

The organization has the right to exclude those, whose behaviour should endanger the safety and regular development of the event, without reimbursement of the participation fee.

By registering for the event, each participant agrees to this regulation and assumes all responsibility for personal injury and property damage, which he may suffer or should cause during the event, renouncing to take any action against organizers and authorities.

Art. 8 - Prizes will be awarded to the following categories:

Italian Vespa Clubs:

- a) Most numerous groups: to the Vespa clubs, which have participated with the highest number of members.
- b) Longest travelled distance: to the Vespa Club, which travelled the longest way with min. 3 vehicles, based on the data provided by the V.C.I. portal.
- c) Group longest travelled distance: to the Vespa Club, which has driven the most kilometres in total, i. e. the distance from the Vespa Club hometown multiplied by the number of its members, based on the data provided by the V.C.I. portal.

International Vespa Clubs:

- a) Most numerous group: to the Vespa Club, which has the highest number of members of the event.
- b) Longest travelled distance: to the Vespa Club, which travelled the longest way.
- c) Group longest distance: to the Vespa Club, which has driven the most kilometres in total, i. e. the distance from the Vespa Club hometown multiplied by the number of its members.

The driven distance is calculated by the use of Google Maps, set on shortest route excluding motorways and toll roads.

Further prizes will be awarded on the initiative of the jury.

Members of the Vespa Club Verona are excluded from the awards.

Art. 9 - The prizes are not cumulative, i.e. the biggest prize excludes the smaller one. No group can be awarded more than one prize.

Art. 10 - Any complaints should be submitted in writing to the event Organizing Committee. The complaint should be accompanied by the sum of Euro 100.- as a deposit. The claim must be submitted within 30 minutes of the publication of the ranking tables.

General claims and claims against unknown subjects will not be accepted.

The event committee will examine the complaint and pronounce his definitive verdict. If the claim is accepted, the deposit money will be refunded. If the claim is rejected, it will be retained by the Organizing Committee.
